

BIG BEAR VALLEY SPORTSMAN'S CLUB SHOOTING RANGE RELEASE

I _____, being of lawful age, in consideration of being permitted to use Big Bear Valley Sportsman's Club Shooting Range, hereinafter referred to as "Shooting Range," hereby understand and agree to accept the risk of bodily injury and/or property damage which I may incur as a result of my use of the Shooting Range facilities and premises. I understand that this risk includes, but is not limited to, being around and using deadly weapons, lead dust inhalation, noise that could cause hearing loss, other toxic airborne materials or objects, and the natural and manmade conditions of the Shooting Range. With this understanding, I agree to indemnify, release, discharge, defend, and hold harmless the Big Bear Valley Sportsman's Club, its officers, range masters, agents, affiliates, assigns, members and employees from and against any and all claims, suits or judgments arising from, or in connection with, my presence on or near the Shooting Range. This Release/Save Harmless Agreement ("hereinafter "Release") relates to any damage, loss or injury to my person and property, even injury resulting in my death, which may be sustained as a consequence of my presence at the Shooting Range, and notwithstanding that such damage, loss or injury may have been caused solely or partly by the negligence of the Big Bear Valley Sportsman's Club, its officers, range masters, agents, affiliates, assigns, members and employees.

By signing this Release, I will forever be prevented from suing or otherwise claiming any damages against the Shooting Range for any property loss or personal injury that I may sustain while at or near the Shooting Range. **I understand that I will not be permitted to use the Shooting Range unless I sign this Release.** I understand that this Release is binding on me, my spouse, my heirs, my executors, administrators, personal representatives and assigns.

I understand that I may be held financially responsible for any damage to facilities or equipment which occurs through my use of the Shooting Range, including any injuries suffered by third parties.

This Release will be construed in accordance with and governed by the laws of the State of California. Any and all lawsuits relating to the Shooting Range and this Release shall be filed in the County of San Bernardino, State of California, which shall have subject matter and personal jurisdiction.

By signing this Release, I certify that I am **NOT PROHIBITED BY ANY LAW OR COURT ORDER** to enter the Shooting Range and that I am lawfully permitted to possess and/ or own a firearm and ammunition. I understand that Law Enforcement may review this Release and may use information obtained herein, against me, if I am prohibited from possessing firearms or ammunition. I further agree to abide by the rules and regulations pertaining to use of the Shooting Range, as well as the Laws of California and the United States, as they relate to firearms and ammunition.

I have read and understand this agreement, and I am aware that by signing this agreement I am waiving certain legal rights which I or my heirs, executors, and/or administrators may have against the Shooting Range. **I am freely and voluntarily executing this Release.**
